	Miss	Gown/dress of choice. Judging will focus on appearance, gown, personality, overall impression.		
Personality Wear	Pre-Teen, Jr Teen, Teen, Miss	Outfit of choice that best suits your personality. Fast-paced modeling to music.		
On-Stage Question	Pre-Teen, Jr Teen, Teen, Miss	An on-stage, unrehearsed question to identify the impromptu public speaking ability of each contestant.		

SPECIAL INFORMATION

- In the event of a tie during the tabulation of scores, all divisions will be broken using the highest overall impression score. For the Miss division, the judges (without interaction from pageant staff) will break the tie; all categories for the Miss division will be evaluated in breaking the tie.
- Scoresheets will be available in the fair office starting August 30.



- 2. Contestants must be female who has always been female, single, never married, without children, and never having been pregnant.
- 3. Contestant must possess strong moral character, have never been convicted of a crime, have any pending criminal charges, or have committed an act or engaged in an activity which is or could be characterized as dishonest, immoral, indecent, or in bad taste. These regulations also apply to improper images/actions on all social media outlets.
- 4. All contestants must enter the division corresponding with their age as of pageant day. All winners are required to sit out one (1) year; they will be eligible to compete again in the 2020 pageant, if they have reached the minimum age for the next age division (may not win the same title/age division twice).
- 5. Contestant line-up will be determined by the order applications are received in fair office, not postmarked (first in, last out).
- 6. All Miss Division contestants are required to attend a mandatory orientation session (July 22 at 3PM, in fair office).
- 7. Evening pageant contestants are required to attend a mandatory rehearsal (August 17).
- 8. The First Runner-Up in each age division must be willing to assume all duties in the event that the winner is unable or unwilling to fulfill her duties.
- 9. The 2018 titleholders are required to attend/participate/abide in/by the following:

Incidents will also be directed to the fair pageant committee/fair board with the potential of the individual(s) being banned from the scholarship pageant program as a contestant; this applies to incidents before/during/after the pageant, if related to the pageant.

All rules, regulations, awards, schedules, and information pertaining to the pageant are subject to change at the discretion of the Directors, the Fair Pageant Committee, and the Board of Directors, if necessary.
